

EXECUTIVE SUMMARY

- Integrated Watersheds Management Project (IWMP) is a flagship programme of Department of Land Resources (DoLR), Ministry of Rural Development (MRD).
- National Remote Sensing Centre (NRSC), ISRO has designed and developed Bhuvan Geo-ICT Web
 portal tools namely Srishti and Drishti for monitoring and evaluation of IWMP watersheds. It uses
 high spatial and temporal resolution sensors viz., Carto-1/2(2.5 m), LISS-IV(5.8 m color).
- Current summary report gives details of Project IWMP-41/2010-11, Anantapuramu District of Andhra Pradesh. The total geographical area of the project is 4,486 ha. It comprises of 4 micro watersheds.
- In the project area 57 Drishti photos were uploaded showing check dams/Rock fill dam, livelihood activities, and remaining showing other activities.
- Water bodies have shown an decrease by 0.13 ha, which correspond to the other land use classes that have been converted into various water bodies in this period.
- Major percentage i.e. 81 % is covered by the agriculture, 7.6 % is covered by Scrub land and remaining by other land use classes.

PROJECT: ANANTAPURAMU — IWMP-41/2010-11 DISTRICT: ANANTAPURAMU, STATE: ANDHRA PRADESH

• The study area falls in Gummagatta Mandal of Anantapuramu district of Andhra Pradesh state. The total geographical area of the project is 4,486 ha. It comprises of 4 micro watersheds. Location Map of the study area is shown in Figure below. Analysis is done for 2010-11 (T0) period (*Batch -II*) projects taking 2018-19 (T5) period satellite images



- Anantapuram has a semi-arid climate, with hot and dry conditions for most of the year. Summers start in late
 February and peak in May with average high temperatures around the 37 °C range and it reaches around 44 °C to 45
 °C.
- Anantapuram gets pre-monsoon showers starting as early as March, mainly through north-easterly winds blowing in from Kerala. Monsoon arrives in September and lasts until early November with about 250 mm (9.8 in) of precipitation. A dry and mild winter starts in late November and lasts until early February; with little humidity and average temperatures in the 22–23 °C (72–73 °F) range. Total annual rainfall is about 22 in (560 mm).
- Anantapuram district receives moderate to good rainfall from July to October month.




Land use and Land cover Changes in the Project

- In matrix table column represents the T0 (2010-11) and row represents the T5 (2018-19)


Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2010-11 to 2014-15)




Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2014-15 to 2015-16)




Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2015-16 to 2016-17)



Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2016-17 to 2017-18)





Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2017-18 to 2018-19)



Land Use and Land Cover changes for Pre and Post treatment dates









- In T0 27 ha of the agriculture area has decreased and it is converted into built up, plantation, scrubland and water body in T1.
- In T1 24 ha of the agriculture area has increased from plantations, scrubland and water body of T0.
- The additional agriculture are coming from waterbody in T1 represents seasonal agriculture.

- In matrix table diagonal elements represent the both periods in the same class and off diagonal elements represents change in between the classes.
- In T3 1.5 ha of the agriculture area has decreased and it is converted into built up and water body in T4.
- In T4 7 ha of the agriculture area has increased from plantations and scrubland of T3.
- The additional agriculture are coming from waterbody in T4 represents seasonal agriculture.

- In matrix table diagonal elements represent the both periods in the same class and off diagonal elements represents change in between the classes.
- In T4 2.6 ha of the agriculture area has decreased and it is converted into built up and mining/dump in T5.
- In T5 28 ha of the agriculture area has increased from plantations and scrubland of T4.
- The additional agriculture are coming from waterbody in T5 represents seasonal agriculture.

Conclusion

- 1. DPR of the project is uploaded on to Bhuvan Portal.
- 2. The LULC shows that there is an increase in Crop land, Built up area, Reservoir / Tanks & decrease in Scrubland as presented in the change matrix for different years.
- 3. There is an decrease of 0.13 Hectares in Reservoir / Tanks area as compared between baseline LU/LC data 2010-11 (T0) & 2018-19 (T5) years.
- 4. There is an increase of 05, 10, 06 & 25 Hectares From T1 to T2, T2-T3, T3 -T4 & T4-T5 respectively and overall increase of 44 Hectares in Crop land area as compared between baseline LU/LC data 2009-10 (T0) & 2018-19 (T5) years.
- 5. There is a decrease of 59 Hectares in Scrubland area as compared between 2010-11 (T0) & 2018-19 (T5) years.
- 6. Farm ponds (18) is visible on IWMP Bhuvan Srishti portal out of Bhuvan Drishti photo of Farm ponds (18) verified from the portal.
