

EXECUTIVE SUMMARY

- Integrated Watersheds Management Project (IWMP) is a flagship programme of Department of Land Resources (DoLR), Ministry of Rural Development (MRD).
- National Remote Sensing Centre (NRSC), ISRO has designed and developed Bhuvan Geo-ICT Web
 portal tools namely Srishti and Drishti for monitoring and evaluation of IWMP watersheds. It uses
 high spatial and temporal resolution sensors viz., Carto-1/2(2.5 m), LISS-IV(5.8 m color).
- Current summary report gives details of Project- IWMP-23/2010-11, YSR Kadapa District of Andhra Pradesh. The total geographical area of the project is 11,260 ha. It comprises of 11 micro watersheds.
- In the project area 61 Drishti photos were uploaded showing check dams/Rock fill dam, New activities of boulder removal, farm ponds, dug out pits etc, and remaining showing other activities.
- Project area as per image analysis has witnessed distinguishable increase in farm ponds, showing new farm ponds or dug out pits and 4 check dams and drainage treatments with 34 ha increase in the area.
- Major percentage i.e. 51% is covered by the agriculture, 36 % is covered by scrubland, 5.11 % is water body area and remaining by other land use classes.

PROJECT: YSR KADAPA - IWMP-23/2010-11 DISTRICT: YSR KADAPA , STATE: ANDHRA PRADESH

• The study area falls in Sri Avadhutha Kasinayana Mandal of YSR Kadapa district of Andhra Pradesh state. The total geographical area of the project is 11,260 ha. It comprises of 11 micro watersheds. Location Map of the study area is shown in Figure below. Analysis is done for 2010-11 (T0) period (*Batch -1*) projects taking 2018-19 (T5) period satellite images



- YSR Kadapa has a semi-arid climate, with hot and dry conditions for most of the year. Summers start in late February and peak in May with average high temperatures around the 38 °C range and it reaches around 44 °C to 45 °C.
- The average annual rainfall of the YSR Kadapa District is 710 mm, which ranges from nil rainfall in January to 137 mm in October. October is the wettest month of the year. The mean seasonal rainfall distribution is 402.4 mm in southwest monsoon (June September), 239.1 mm in northeast monsoon (October December), distribution of rainfall in season wise 56.7 % in south west monsoon, 33.7 % in north east monsoon period.




MONITORING IN THE PROJECT AREA

Natural Color Composite — 2010-11 to 2018-19






Land use and Land cover Changes in the Project

- In matrix table column represents the T0 (2010-11) and row represents the T5 (2018-19)


Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2010-11 to 2014-15)




Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2014-15 to 2015-16) Scale: 1:10000




Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2015-16 to 2016-17)




Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2016-17 to 2017-18)




Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2017-18 to 2018-19)












Agriculture to Water body










- In T2 440 ha of the agriculture area has increased from mining/dump, plantations and scrubland of T1. The additional agriculture are coming from waterbody in T2 represents seasonal agriculture.

- In T3 351 ha of the agriculture area has decreased and it is converted into Built-up, plantation and water body in T4.
- In T4 293 ha of the agriculture area has increased from plantation and scrubland of T3.
- The additional agriculture are coming from waterbody in T4 represents seasonal agriculture.

- In matrix table diagonal elements represent the both periods in the same class and off diagonal elements represents change in between the classes.
- In T3 106 ha of the agriculture area has decreased and it is converted into Built-up, plantation and water body in T4.
- •In T5 376 ha of the agriculture area has increased from plantation, scrubland and water body of T4.
- The additional agriculture are coming from waterbody in T5 represents seasonal agriculture.

Conclusion

- 1. DPR of the project is uploaded on to Bhuvan Portal.
- 2. The LULC shows that there is an increase in Crop land, Built up area, Reservoir / Tanks & decrease in Scrubland as presented in the change matrix for different years.
- 3. There is an increase of 34 Hectares in Reservoir / Tanks area as compared between baseline LU/LC data 2010-11 (T0) & 2018-19 (T5) years.
- 4. There is an increase of 352, 247, 229 & 270 Hectares From T0 to T1, T1-T2, T2-T3 & T4-T5 respectively and overall increase of 1,041 Hectares in Crop land area as compared between baseline LU/LC data 2010-11 (T0) & 2018-19 (T5) years.
- 5. There is an increase of 357 ha of the Plantation/Horticulture area has been increased between 2010-11 (T0) & 2018-19 (T5) years.
- 6. There is a decrease of 1,457 Hectares in Scrubland area as compared between 2010-11 (T0) & 2018-19 (T5) years.
- 7. Farm ponds (6) is visible on IWMP Bhuvan Srishti portal out of Bhuvan Drishti photo of Farm ponds (6) verified from the portal.
