

#### EXECUTIVE SUMMARY

- Integrated Watersheds Management Project (IWMP) is a flagship programme of Department of Land Resources (DoLR), Ministry of Rural Development (MRD).
- National Remote Sensing Centre (NRSC), ISRO has designed and developed Bhuvan Geo-ICT Web
  portal tools namely Srishti and Drishti for monitoring and evaluation of IWMP watersheds. It uses
  high spatial and temporal resolution sensors viz., Carto-1/2(2.5 m), LISS-IV(5.8 m color).
- Current summary report gives details of Project IWMP-55/2012-13, Kurnool District of Andhra Pradesh. The total geographical area of the project is **4,916** ha. It comprises of 11 micro watersheds.
- In the project area 323 Drishti photos were uploaded showing checks & plugins, Field bunds and remaining showing others.
- Water bodies have shown an increase by 16 ha, which correspond to the various water bodies that have been converted into other land use classes in this period.
- Major percentage i.e. 88 % is covered by the agriculture, 6.8 % is covered by scrubland, 2.5 % is covered by water body and remaining by other land use classes.

# PROJECT: KURNOOL - IWMP-55/2012-13 DISTRICT: KURNOOL, STATE: ANDHRA PRADESH

• The study area falls in Koilkuntla Mandal of Kurnool district of Andhra Pradesh state. The total geographical area of the project is **4,916** ha. It comprises of 11 micro watersheds. Location Map of the study area is shown in Figure below. Analysis is done for 2012-13 (T0) period (*Batch -1*) projects taking 2020-21 (T5) period satellite images



- The climate is tropical with temperatures ranging from 26 °C to 46 °C in the summer and 12 °C to 31 °C in the winter. The average annual rainfall is about 705 millimeters (28 in).
- The average annual rainfall of the district is 665.5mm, which ranges from nil rainfall in January and December to 139.6 mm in September. August and September are the wettest months. The mean seasonal rainfall distribution is 459.1mm in southwest monsoon (June September), 133.7mm in northeast monsoon (Oct-Dec), 1.9 mm rainfall in Winter (Jan Feb) and 70.8 mm in summer (March–May).

## Natural Color Composite overlaid with Project boundaries and high detail stream network






#### Site Wise Changes in the Project


- Impacts of the activities carried out are presented through combination of Drishti and Srishti captures.


#### Land use and Land cover Changes in the Project

- Captures are also provided wherever changes are observed in satellite images, that may match expected activity related impact, even though they don't have Drishti report yet.
- The result obtained for the period T0 to T5 are given in the change matrix table.
- In matrix table column represents the T0 (2012-13) and row represents the T5 (2020-21)


#### Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2012-13 to 2016-17)




#### Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2016-17 to 2017-18)




#### Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2017-18 to 2018-19)



#### Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2018-19 to 2019-20)




#### Comparative assessment of Land Use and Land Cover for Pre and Post IWMP implementation (2019-20 to 2020-21)







Scrub to Farm pond









- In matrix table diagonal elements represent the both periods in the same class and off diagonal elements represents change in between the classes.
- In T1 39 ha of the agriculture area has decreased and it is converted into Built-up, plantation, scrubland and water body in T2.
- In T2 160 ha of the agriculture area has increased from plantations, scrubland and water body of T1. The additional agriculture are coming from waterbody in T2 represents seasonal agriculture.

- In T2 2.6 ha of the agriculture area has decreased and it is converted into Built-up, plantations and water body in T3.
- In T3 69.5 ha of the agriculture area has increased from scrubland and water body of T2.
- The additional agriculture are coming from waterbody in T3 represents seasonal agriculture.

- In T3 12.8 ha of the agriculture area has decreased and it is converted into Built-up, plantations, scrub and water body in T4.
- In T4 41 ha of the agriculture area has increased from scrubland area of T3.
- The additional agriculture are coming from waterbody in T4 represents seasonal agriculture.

- •In T5 1.3 ha of the agriculture area has increased from scrubland area of T4.
- The additional agriculture are coming from waterbody in T5 represents seasonal agriculture.

- In matrix table diagonal elements represent the both periods in the same class and off diagonal elements represents change in between the classes.
- •In T4 6.04 ha of the agriculture area has decreased and it is converted into Built-up and water body in T5.
- •In T5 13 ha of the agriculture area has increased from scrubland and water body of T4.
- The additional agriculture are coming from waterbody in T5 represents seasonal agriculture.

# **Conclusion**

- 1. DPR of the project is uploaded on to Bhuvan Portal.
- 2. The LULC shows that there is an increase in Crop land, Built up area, Reservoir / Tanks & decrease in Scrubland as presented in the change matrix for different years.
- 3. There is an increase of 16 Hectares in Reservoir / Tanks area as compared between baseline LU/LC data 2012-13 (T0) & 2020-21 (T5) years.
- 4. There is an increase of 120, 67, 28, 1.3 & 8 Hectares from T0-T1, T1-T2, T2-T3, T3-T4 & T4-T5 respectively and overall increase of 261 Hectares in Crop land area as compared between baseline LU/LC data 2012-13 (T0) & 2020-21 (T5) years.
- 5. There is an increase of 4.6 Hectares in plantation/horticulture area from 2012-13 (T0) & 2020-21 (T5) years.
- 6. There is a decrease of 285 Hectares in Scrubland area as compared between 2012-13 (T0) & 2020-21 (T5) years.
- 7. Farm ponds (19) is visible on IWMP Bhuvan Srishti portal out of Bhuvan Drishti photo of Farm ponds (19) verified from the portal.
